**Biographical Information Overview of Interview:** Dr. Max Pierson was born on September 20, 1945 near Princeton, Illinois, and attended one room schools for his first five years of schooling, graduating from Princeton High School in 1963. He earned his B.S. from the University of Illinois and a Masters Degree and later a Doctor of Education degree from Illinois State in 1976. He served as a lieutenant in the U.S. Army (1968-1970) in Vietnam. His work experience included the districts of Gridley, Pontiac-Esmen, Cornell, and Savanna, and later Western Illinois University (WIU). He served thirteen years as Superintendent and thirteen years on the staff at Western, including three years as Department Chair/Educational Administrator and Supervisor.

Dr. Pierson has written numerous feasibility studies regarding school reorganization in northern, western, and central Illinois. Some of his publication topics include writings on Random Drug Testing, Alternative Certification, Board Member Training, Property Tax Extension Limitation Act, School District Reorganization, Superintendent Selection, Administration/Principal Evaluation, School Law, Entrepreneurship Education, Health and Life Safety, School –Business Partnerships, School Finance Issues, Tech Prep and Rural revitalization. Currently he serves on the Wesley Willows Village Board of Directors.
