Abstract

Biographical Information and Synopsis: Marian Goza was born in 1930, in Springfield, Illinois, to John and Clara Ritchie. Her father was a night watchman at S.S. Kresge and her mother worked as a custodian at CILCO. She had one older brother, John. She attended Enos Grade School and Springfield High School. She attended Springfield Junior College for one year. She then transferred to Lincoln University in Jefferson City, Missouri, so that she could experience going to an all-black school, since she had grown up primarily around Caucasians. She left Lincoln University in 1952 and came to Springfield to work. She had married Robert Goza, a Missouri native, while living in Missouri. Upon her return, she was hired in the laboratory at Memorial Medical Center and attended medical technology school. She became a medical technologist and worked there for 38 years. After her mother passed away from cancer, Marian went to Sangamon State University and finished her degree in Biology. Marian stated that she never felt discrimination in the workplace. She believed that it might have been due to the fact that she did not have a lot of patient interaction. Marian also talked about her four children: Cheryl, Michael, Roger, and Jeannette, and being involved in Girl Scouts and Boy Scouts. She was also active in the IMTA (Illinois Medical Technology Association) and the ASMT (American Society of Clinical Pathologists. Her husband was very active in the NAACP and every summer they would travel to many different locations for the conferences. Marian retired in 1992 and then worked for Alice Campbell Temporary Services and the Illinois Funeral Directors Association for a few years.
