## Kathleen Sullivan, Illinois Statecraft, ISE-A-L-2011-059

**Biographical Information Overview of Interview:** Kathleen (O'Connor) Sullivan was born on January 22nd, 1934 in Trinidad, West Indies, and grew up there until she came to Scarsdale, New York in 1950 to work as an au pair for her aunt and uncle. She met Jerry Sullivan in 1951, and the two were married in 1953. From that time on, she viewed herself as a career homemaker, raising six children in a very successful marriage. Kathleen was also always very involved in church and community activities, and was intrigued early on by American politics. She was an early supporter of Phyllis Schlafly, a vocal conservative who in the early 1960s spoke passionately about the nuclear arms race. Like Schlafly, Sullivan was a strong supporter of Senator Barry Goldwater's 1964 presidential campaign.

In the 1970s, Sullivan became Mrs. Schlafly's chief lieutenant in the long and contentious fight in Illinois over the adoption of the Equal Rights Amendment. She discussed this fight in considerable detail, as well as the cultural and political environment in Chicago during that era. She discussed the early activism of the Students for a Democratic Society, and of conflicts within the Catholic Church in the greater Chicago region. She was a staunch opponent to the Roe v Wade Supreme Court decision in 1973, and a vocal opponent to the American feminist movement and the National Organization for Women. She was the Illinois Chairman in the Stop ERA movement until its ultimate defeat in 1982.

In 1990, and again in 1992, Mrs. Sullivan ran for Congress in Illinois's 10th Congressional District, running on the issues of tax relief, health and family. She ran a strong campaign, but was defeated both times in the Republican primary by liberal Republican incumbent John Porter. Throughout the 1980s through 2009 she was the driving force behind Project Reality, which promoted Abstinence Education in Illinois's schools and nationwide until the Governor Rod Blagojevich administration defunded the project in November, 2007.
