Abstract

Biographical Information/Overview of Interview: Tommy Ray (T. Ray) McJunkins was born in Little Rock, Arkansas on December 31, 1962 and grew up in North Little Rock. He was raised by a single mother who made sure that her children received a strong religious foundation. Tommy began working at a Sears store at age sixteen, and over the years distinguished himself and found mentors who were eager to help him. He gave his first sermon at age nineteen after a close friend passed away. In February 1984 he joined the Air Force, and following basic training, he was posted to McConnel Air Force Base in Wichita, Kansas.

T. Ray left the Air Force in February 1988 and worked at a Boeing plant in Wichita while he also continued to preach at his church. In 1990 he was asked to serve as interim pastor at St. John's Missionary Baptist Church in Salina, Kansas, becoming their pastor in August of 1990. He received a BA degree in 1992 from Kansas Wesleyan University, then took courses at Midwestern Baptist Theological Seminary and received a Bachelor of Christian Ministry degree in 1995, and a Master of Divinity degree in Christian Ministry in 1998.

At this time, he became pastor at Bethel Baptist Church in Longview, Texas. He soon began looking for another call, applying for a vacancy at the Union Baptist Church in Springfield, Illinois. In 2002 he accepted a call from that congregation. Shortly after arriving, Pastor McJunkins led the congregation through a major expansion project while continuing to grow the congregation. At the time of this interview he was still pastoring to that congregation. During the interview, Pastor McJunkins spoke at length about his Baptist faith, and also his involvement in the larger community on a variety of issues.
