Abstract

Biographical Information Overview of Interview: Dave Blanchette was born on January 23, 1960 in Kankakee, Illinois. The family moved to Jacksonville, Illinois in 1972. He earned a Bachelor of Arts degree in Journalism at MacMurray College in Jacksonville in 1982. Thereafter, Dave worked as a reporter and the radio news director at WJIL-WJVO Radio in Jacksonville from May 1979 through November 1987, then he became the Public Information Officer (PIO) for the Illinois Department of Mental Health and Developmental Disabilities. In 1989 he moved to the Illinois Historic Preservation Agency (IHPA), serving as agency PIO until 2013. (See David interview in *IHPA Legacy* project, which covers the IHPA years.)

In March, 2013 Blanchette joined the Governor Pat Quinn (Democrat) administration, working in the governor's press office. His specific assignment for Quinn was to maximize the amount of positive press the governor received from the media, something Blanchette accomplished by sending out scores of press releases targeted at local communities, highlighting one of Governor Quinn's many initiatives, most of which stemmed from his 'Illinois Jobs Now' initiative. Dave talked extensively about Governor Quinn's leadership and management style, and what it was like to accompany him throughout the state. He also discussed Quinn's 2014 gubernatorial campaign in detail, a campaign in which his opponent was wealthy Republican Bruce Rauner. Although Blanchette was not part of the campaign team, in his official capacity he was able to observe Quinn's campaign and political style close up.
