Abstract

Taylor Pensoneau, Illinois Statecraft – Quinn, ISQ-A-L-2020-0??

Biographical Information/Overview of Interview: Taylor Pensoneau was born on October 20th, 1940 in Belleville, Illinois. He decided early on to go into journalism, earning his college degree from the University of Missouri-Columbia in 1962. Pensoneau covered the Illinois Statehouse beat for the St. Louis *Post Dispatch* from October 1965 through January 1978. During that time, he closely followed the governorship of Dan Walker, and became acquainted with one of Walker's young staff members, Pat Quinn.

Pensoneau first encountered Quinn when Quinn was helping to run Walkers gubernatorial campaign in southern Illinois in 1971-72. He got to know Quinn during that campaign, then followed Quinn's career in the Walker administration, first in a role as ombudsman for Governor Walker, then his transfer to the Department of Transportation, where Pensoneau recalls Quinn assisted on personnel matters. That position was often considered one dealing with patronage issues, a practice which was entirely legal and accepted at the time. In early 1975 Pensoneau wrote a series of articles about allegations in the Department of Transportation and other departments of ghost payrollers. These were often young Quinn staffers who on paper worked at a specific agency but in reality performed work for the governor's office, in some cases tasks of a political nature. Many over the years have alleged that Pat Quinn was one of Walker's ghost payrollers. Pensoneau dd not cite Quinn by name in any or his articles, nor does he know if that was actually the case for Quinn.
