# Abstract

## George Pempek, *Veterans Remember*, VRK-A-L-2009-011

**Biographical Information Overview of Interview:** George Pempek was born on January 30, 1930 in Blackwell, Wisconsin where his father worked in a lumber camp. During the depression, his father worked in a Civilian Conservation Corps camp near Blackwell, Wisconsin. Life for the family was tough and primitive, but life improved a bit during World War II.

Pempek joined the Regular Army in February of 1947, and following training at Ft. Lewis, Washington and Ft. Meade, Maryland, where he received training as a firefighter. He was assigned to the 31st Infantry Regiment, 7th Infantry Division, then serving occupation duty near the 38th parallel in South Korea. By 1949 he was reassigned to Hawaii and the 5th Regimental Combat Team, working in the 3rd Battalion's Intelligence section. In late July, 1950, the 5th RCT was deployed to Korea, arriving in time to participate in the defense and breakout from the Pusan Perimeter. Over the next year, Pempek continued to serve in the 3rd Battalion's Intelligence and Reconnaissance section, accompanying the unit, then attached to the 24th Division, as it advanced toward the Yalu River in November, 1950. When the Chinese launched their massive offensive in late November, Pempek's unit was pushed back down the spine of Korea until the line stabilized below Seoul. The front line moved up and down the center of Korea over the next few months in a series of attacks and counterattacks. Pempek returned to the United States in mid-1951, and stayed in the Army.

George was reassigned to South Korea again in 1962-63, this time as the Sergeant Major for the 8th Army, seeing only limited improvements. He returned to Korea in 1999 as a tourist, and was impressed by the vast strides the South Koreans had made. He passed away on January 23, 2018.
